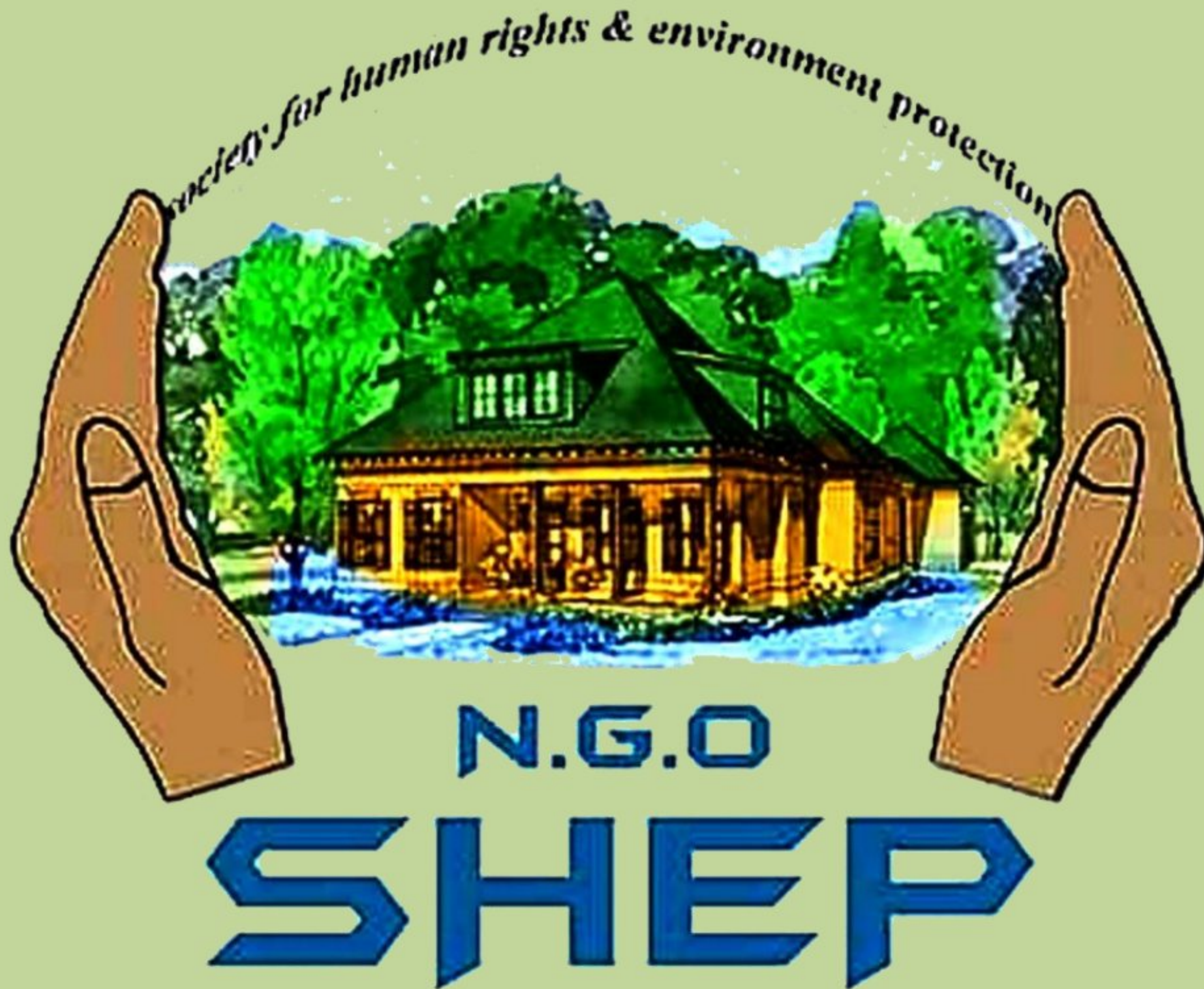

The Society for Human Rights & Environment Protection remains committed to ongoing efforts in promoting women's rights. Future initiatives will include:

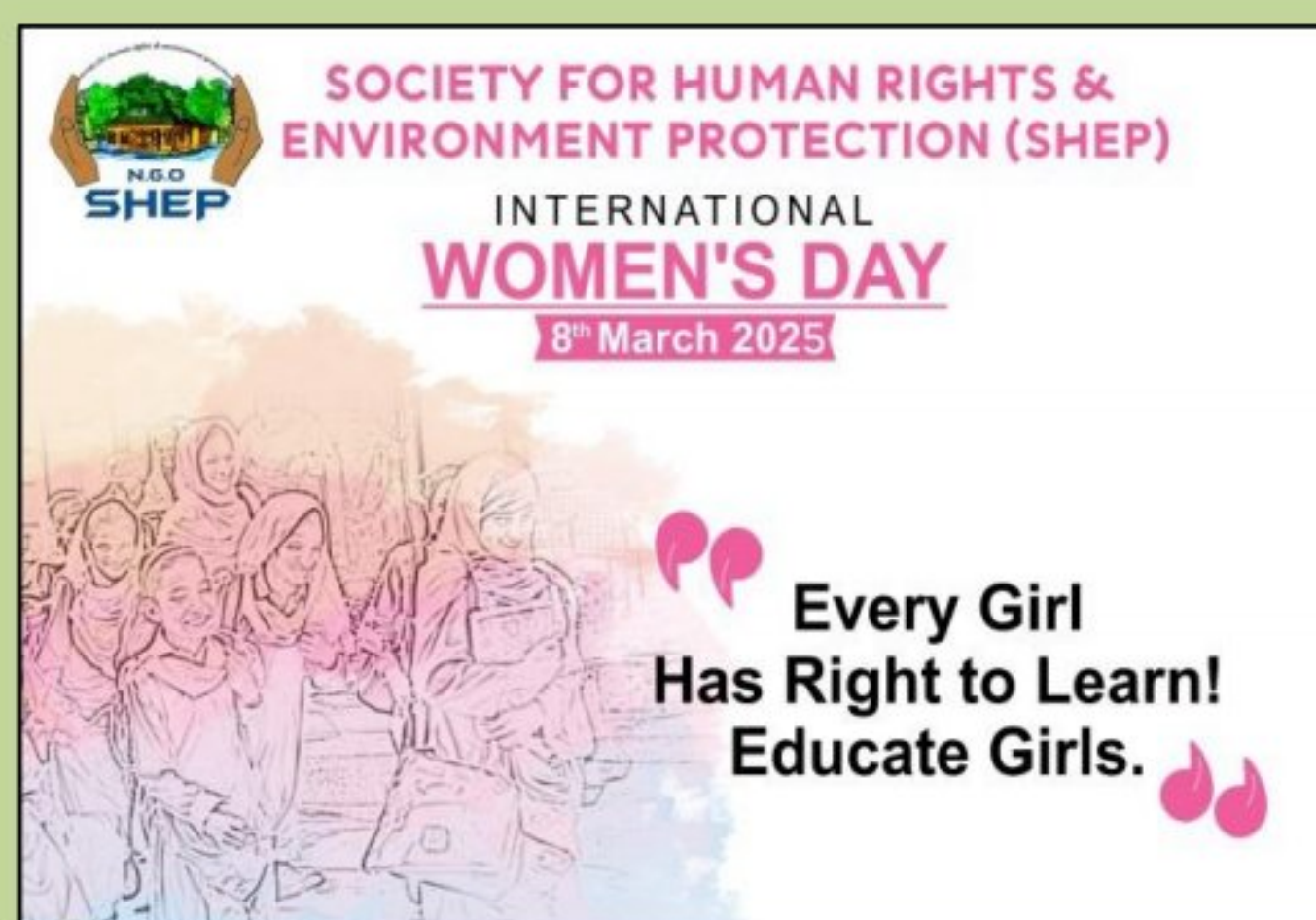
- **Mentorship programs for young girls:** Encouraging young women to take up leadership positions and develop essential skills.

WORLD HUMAN RIGHTS DAY
